Why leave a gift in your Will to St Mary's House of Welcome?

Thank you for considering leaving a gift in your Will and making a lasting and invaluable commitment to make a difference to the lives of some of the most vulnerable people in our community.

Many of those who come to St Mary's House of Welcome for help experience multiple issues: sleeping rough, drug addiction, poverty, childhood trauma, mental illness, institutionalization, street drinking, all of which adds up to chronic social and health problems.

Our open-door policy means we are often the first point of contact for people when they need a place to eat, wash and access essential services. In addition to basic services, we also provide case management, psycho-social support and a comprehensive social inclusion program.



St Mary's House of Welcome only receives around 60 per cent of its funding from government. Instead, we rely on the generosity of our supporters to fund around 40 per cent of our other vital programs such as the meal service, amenities and social support activities.

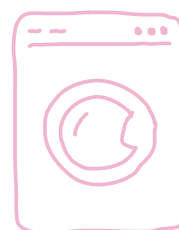
Last year, we were able to provide some of the most vulnerable people in our community with:

- » **146,928** substantial, nutritious meal packs
- » Over **4,200** warm showers, toiletry packs and fresh clothing
- » Over **3,250** emergency food hampers
- » **1,000** support sessions with qualified community workers
- » **550** social inclusion activities such as art/craft, gardening, fishing and wellbeing groups.

How to leave a gift in your Will

We recommend that you speak to your solicitor or legal practitioner before making a Will. They can advise you on how best to ensure your wishes and intentions are met.

Types of gifts:

- » **Residuary:** A residual gift is the what is left of your estate or percentage thereof after your loved ones have been provided for and expenses have been deducted.
- » **Specific:** A gift of a specific item such as shares or property.
- » **Pecuniary:** A specific sum of money.
- » **Percentage:** A percentage gift of the residual or entire estate.

Wording for your solicitor

"I give and bequeath to St Mary's House of Welcome (ABN: 54 050 278 754) for its general purposes, free of all duties:

The residue, or ____% of my residual estate / ____% of my entire estate after other gifts have been distributed, or

The sum of \$ _____, or _____
(item/asset)"



Frequently Asked Questions

Can I add a gift to St Mary's House of Welcome to my existing Will?

Yes, you can make changes to your existing Will. Simply consult your solicitor to create a Codicil. Often certain life events trigger changes to be made to your existing Will such as marriage, having a child or buying a house. These are good times to consider adding a gift in your Will to the causes that are important to you.

Do I have to notify St Mary's House of Welcome that I have left a gift in my Will?

We would like the opportunity to be able to thank you personally but You are under no obligation to let us know your intentions. We understand that this is a very personal decision and we will treat your decision and information with the strictest confidence.

How do I leave a gift in my Will and take care of my loved ones?

Taking care of loved ones is an important consideration for many of us. After remembering them you can consider leaving a gift to St Mary's House of Welcome. We recommend sharing your intentions with friends and family so that they understand why supporting the chronically homeless is important to you.

How will my gift help?

Every bequest helps us enable future generations of people who are homeless, disadvantaged and socially isolated to be nourished and safe, to have practical support and to find hope, experience belongingness and achieve to their full potential.

Does it matter the size of the gift?

St Mary's House of Welcome is incredibly grateful for all gifts, big or small, knowing they make a real difference to the lives of people who are chronically homeless or extremely isolated. Even a residual gift of 5% can have a significant impact on people's lives now and in the future.
