

More than ever, person-centred care is widely accepted as a standard but a tension still exists within the sector between offering this level of care, regulatory changes and the level of resources available.

Meaningful Ageing Australia is on a mission to help provide the sector with the leadership and the resources they need to be able to ensure every person in their care – be it residential or community-based – experiences meaning, purpose and connectedness in their lives.

This means advocating on our members' behalf and elevating the role of advanced practitioners and ensuring their professionalism is recognised. It means creating practical resources and programs to support aged care providers to build staff confidence and capability so that they can integrate emotional support and spiritual care into their day-to-day work.

Ensuring older people can continue to experience meaning, purpose and connectedness *is* spiritual care.

#### We farewelled Ilsa Hampton

We farewelled Ilsa Hampton in February 2022.

Ilsa was involved with our organisation since its inauguration, serving on the Board from 2013 to 2016.

During her 6 years as CEO, Ilsa led us through a period of significant industry reform. The Royal Commission into Aged Care Quality and Safety was conducted and reported its findings, new Aged Care Quality Standards were introduced and a pandemic hit, which left older people grappling with its impacts.

Ilsa's leadership ensured that Meaningful Ageing Australia has had a seat at the table in contributing to how the future of aged care will be shaped. We are grateful for her passionate advocacy for quality of life for older people.

Her work has also seen us grow from a collective of 22 Sponsor Organisations to the 123 membership-based not-for-profit organisation we are today.

Everybody at Meaningful Ageing Australia - members of the Board, staff, our members and the sector as a whole - was saddened to see Ilsa leave but also full of gratitude and joy for her having been such an instrumental part of our journey.

# We continued to provide member support and practical resources

The period of December 2021 to February 2022 was a particularly rough one for our sector, already fatigued by the toll of Covid.

We continued to provide our members with access to our *COVID-19 Resource Package*. And we added to it by collaborating with the inventor of Window Therapy and Creative Elder Engagement Specialist, Maurie Voisey-Barlin.

The Elder & Dementia Engagement using Zoom: COVID Quick Guide has since become an important resource for many of our members.

At the start of 2022, we also conducted a number of interviews with members about the role of spiritual care in caring for those older people living with dementia. These interviews were also an opportunity to listen and provide some space for them to process what they were going through.

And we kickstarted our 2022 webinars with some tools and practices to nurture self care in the face of overwhelm and burnout.

During this year we continued to develop *Meet Akira*, our innovative and interactive learning experience designed for personal care workers in community and residential aged care.

In February, we again worked with Portable to hold a co-design workshop involving personal care workers, residents, and those who have experience with end of life support. Through this co-design event we explored the possible scope and content for our next *Akira* story, which will focus on end of life.

Chapter 1 (2020/1): *Meet Akira* – a story to show what spiritual care looks like on an ordinary day

Chapter 2 (2023): *Akira says goodbye -* a story about how to respond to death and dying

This year we have also developed a relationship with Methodist Homes (MHA), the largest charity care provider in the UK, to enable them to bring Meet Akira to their workforce as part of their stated 3-year End of Life Care strategy.

MHA supports more than 19,200 older people each year through care homes, retirement living and community groups embedded in local communities.

## A much appreciated resource

#### **Multifaith Practices**

'We have a new resident who is from India and of Hindi religion. One afternoon we were sitting outside in the sun meeting together. After we started talking, I suddenly remembered about my *Multifaith Practice* resource book from Meaningful Ageing and ran back to get it. My new resident and I read through a portion of the Hindi section together. He loved the pictures and that I had a resource to be able to help explain about his religion. While we were talking one of the care staff who speaks the same language as him came by to see what we were doing. She explained that though she was from Nepal she shared the same religion and could speak the same language. She really added to our conversation helping translate at times when we couldn't work it out in English. I was really buoyed by this interaction as was the resident and staff member and it meant that I could complete his spiritual assessment in a meaningful way.'

# We continued to host our professional development events online

**Open-access webinar:** a free 30-minute offering each month on a themed topic, with guest presenter, allowing anyone in the community to attend.

National Community of Practice: a monthly, 1-hour members-only Zoom meeting for frontline teams with a particular interest in social, emotional and spiritual wellbeing. The workshop have a theme, a member guest presenter, a discussion focus and practical facilitated space for sharing ideas.

National Forum: in September 2021, close to 190 attendees from across Australia joined us on Zoom to listen, learn, share and participate in sessions that were of high relevance to our members and wider aged care community.

Our guests and speakers included Amy Laffan, First Asst Secretary, Quality & Assurance Division, Department of Health; David Panter, then CEO, ECH; Sonya Smart, CEO, VMCH; Mandy Salomon, co-founder and CEO, Mentia; Diana Harrison. Project Coordinator, ELDAC; Professor Yvonne Wells, La Trobe University; and Michelle Richardson, Program Lead, Blue Care Community.

**Executive Leadership Series:** in April 2022, we held a special event – *Celebrating Excellence in Aged Care* – facilitated by Crazy Might Work, an award-winning innovation agency who work in aged care innovation across Australia.

The focus of this 90-minute CEO session was on the power of storytelling in influencing positive behaviours and mindsets as well as supporting organisational strategy.

Education events: as accreditors focus more and more on how service providers are providing spiritual care and ensuring multifaith and diversity is reflected in the care provided, we continue to provide an important avenue of professional development in our online education training sessions such as *Introduction to Spiritual Care* and *ConnecTo*.



For International Spiritual Care Week 2021, we updated and reissued our summary of spiritual care research literature to cover the period 2010—2021. Our resource, What is the Value of Spiritual Care?, compiles evidence of the value of spiritual care from aged care and beyond.

# We strengthened our relationships and embarked on new collaborations

There are always opportunities to collaborate, support and co-create with other organisations working in the sector and this past year was no exception.

# We continued our advocacy and engagement with government and peak bodies

As a peak body, the purpose of our advocacy efforts is always on behalf of our members and the older people they care for.

The relationships we have formed, and our ongoing participation in advocacy and engagement, allow us to play an important role in the way we engage with government on the subject of aged care and the ways we can work together to ensure improvements and innovations in how aged care services are provided.

This has been particularly noteworthy this past year through the election and change of federal government.

In August 2021, we submitted a response as part of the consultation process for Palliative Care Australia's Standards for Generalist Palliative Care. That process included our creating the opportunity to involve interested members and some of our research consultants to share their own response, concerns and ideas.

In November, we were one of 25 peak bodies who backed OPAN's call for the new Aged Care Act to be rights-based.

In December, we were in Canberra meeting with Dept of Health about the value and role of *ConnecTo*.

In February 2022, we petitioned then Ministers Hunt and Colbeck on behalf of our members to review eligibility for the Workforce Retention Bonus. As part of the National Aged Care Alliance (NACA), we sent a letter to the Prime Minister to do the same. We also had the opportunity to put the question directly to then Minister Colbeck during a NACA meeting.

In May, we hosted a special pre-election webinar to discuss some of the issues and perspectives that could hurt or heal the sector, particularly when we look through the lens of emotional wellbeing, human rights and quality of life.

And we are staying in ongoing conversations with Department of Health, Ageing and Aged Care Division and Nick Morgan, Assistant Secretary, Support at Home Reform Branch in particular about the inclusion of spiritual and pastoral care in the redesign of the new Home Care Package.

### **Our community**

What unites us is a moral mandate to help older people to flourish.

### **Our history**

In June 2009, a multi-faith Steering Committee was created to develop a vision, mission statement and objectives for an association be formed to support the future of pastoral and spiritual care for older people.

By September 2012, there were 22 Sponsor Organisations. Pastoral and Spiritual Care of Older People (PASCOP) was incorporated in December 2012.

In early January 2013, Dave Petty commenced as the inaugural Executive Officer. On 5 February 2013, a meeting of Sponsor Organisations appointed an inaugural board.

In May 2014, PASCOP was launched as a membership-based not for profit and began to recruit new members. Sponsors were invited to convert to members at the end of their sponsorship period in 2015.

In February 2016, Dave Petty handed over leadership to Ilsa Hampton, who had served on the board since the organisation's inauguration.

To communicate our intent more clearly, in April 2016 our members voted to change our name from PASCOP to Meaningful Ageing Australia.

At the AGM on 3 December 2019, members voted to change the organisation's structure to a Company Limited by Guarantee, which was approved by ASIC on 5 June 2020.

In 2020-21, we successfully applied to become recognised as a public benevolent institution with the Australian Charities and Not for Profits Commission, followed by being endorsed with deductible gift recipient status from the Australian Taxation Office.
